

### Selling price and revision of revision of pricing

### Validity of the order

The quantities as well as the frequency of the weekly delivery stipulated at the front of this document are agreed on for an indefinite time, from the 1<sup>st</sup> delivery date defined at the front of this document. The customer may amend the quantity and delivery frequency ordered through Fruit@Office with one week's notice.
